Section C: Worship and Teaching

This section should include questions relevant to all CCI ministries, as we all have worship at heart, and can all influence guests whether through programming, on-site activities, personal interaction with guests as hospitality is offered, literature made available, notices and posters in the venue, or social media.

Sections D-G: Operations and Energy; Water and Cleaning; Catering and Waste; Land Management

All ministries have some sort of office base, but not all own a venue for camps.

- For those with a venue – these questions should be answered on the basis of their offices, venue, ministry staff housing, and the land these are on.
- For those without their own venue – answer these questions on the basis of your office base, any permanent staff housing, and the influence you are able to have on the venues you rent (through suggestions, comments offered on evaluation forms, or in private conversations with those responsible for managing the campsites you rent).

Not all ministries provide catering. If you do not cater for camps, please answer food related questions from the perspective of permanent / live-in staff.

You can also answer “Not applicable” to any question.

C: Worship and Teaching

- 1** We have a dedicated outdoor church area for staff and campers to worship God in nature.
- 2** We offer worship trails or activities to encourage outdoor worship.
- 3** We provide literature to encourage people to enjoy God's creation and worship the Creator.
- 4** Nature appreciation activities are included in the programme for camps.
- 5** We use the wonders of creation to point campers to our Creator God.
- 6** During camps, campers are introduced to environmental issues and what they can do about them.
- 7** Environmental education activities are included in the programme for camps.
- 8** Practical conservation work is included in the programme for camps.
- 9** Citizen science projects are included in the programme for camps.
- 10** We are committed to regularly praying for environmental issues.
- 11** Staff seek to encourage and spur one another on towards "living lightly" (minimising our negative impact on the planet through the way that we live) – sharing ideas and helping one another implement changes.
- 12** Our Leadership Team have made a commitment to work at improving environmental care.
- 13** Staff and students receive teaching and training (including Bible study) in environmental issues and creation care, and are encouraged to take action in their personal lives and as part of their work.
- 14** We share the Bible's message of creation care with the community around us.
- 15** We get involved in wider community projects caring for the natural world.
- 16** We engage with our local council, mayor or government leaders on environmental matters.
- 17** We participate in campaigns concerning local, national or global environmental issues.

- 18** We support Fairtrade initiatives and buy Fairtrade products where possible.
- 19** Our newsletters and/or social media posts clearly show our commitment towards improved environmental stewardship, and encourage others to join us in caring for God's creation.
- 20** We have linked up with local conservation organisations and environmental schemes to help us in our care of creation (e.g. A Rocha; Eco Church UK; etc.).

D: Operations and Energy

- 1** We have carried out an energy audit for our venue.
- 2** We have set targets for improving energy efficiency and reducing our carbon footprint.
- 3** We use solar power, or other renewable energy, to heat our water.
- 4** We have solar panels to supply our electricity (other than for heating water).
- 5** We use renewable energy produced onsite by other means (e.g. geothermal, biofuels, wind turbine, etc.).
- 6** We use a green energy supplier.
- 7** We have LED light bulbs fitted.
- 8** We encourage staff and campers to turn off lights whenever they're not needed.
- 9** We have a policy in place to limit energy use for floodlighting and security lighting.
- 10** We have insulated the roofs of our buildings to prevent heat loss.
- 11** We have insulated the walls of our buildings to prevent heat loss.
- 12** We have double glazed our windows to prevent heat loss.
- 13** We minimise our use of heating in winter, turning thermostats down wherever possible.
- 14** We minimise our use of air conditioners in summer.
- 15** We use wood from sustainable sources for firewood.
- 16** We use recycled or sustainably-sourced paper for our office and administrative work.
- 17** We minimise printing of paperwork, print double-sided wherever possible and reuse scrap paper before recycling.
- 18** We have energy efficient fridges and freezers.

- 19** We have energy efficient dishwashers.
- 20** We seek to reduce our carbon footprint through travel by minimising journeys, lift-sharing or using public transport whenever possible.
- 21** We seek to reduce our carbon footprint through travel by walking or cycling if possible.
- 22** We use electric vehicles for camp purposes in order to reduce our carbon footprint.
- 23** We seek to reduce our carbon footprint through travel by avoiding flying whenever possible.
- 24** We seek to reduce our carbon footprint through travel by offsetting our travel.

E: Water and Cleaning

- 1** We have signs encouraging people to save water.
- 2** We provide water-saving handwashing options (waterless hand sanitiser; 'tippy taps'; or other similar systems).
- 3** We encourage staff and guests to notify maintenance of any leaking taps, and fix them within 24 hours.
- 4** We have taps which turn off automatically.
- 5** We have fitted reduced-flow taps.
- 6** We have fitted reduced-flow shower heads.
- 7** We encourage people to take short showers (less than 2 mins).
- 8** We provide buckets so that shower water can be collected for toilet flushing.
- 9** We flush with grey water where possible.
- 10** We have dual flush toilets.
- 11** We have waterless urinals.
- 12** We have installed waterless composting toilets.
- 13** We treat our sewage on-site in an environmentally friendly way.
- 14** We have waste bins and appropriate signage in all toilets to discourage anyone from throwing sanitary products into the toilet.
- 15** We use recycled or sustainably sourced toilet paper.
- 16** We use environmentally friendly cleaning products.
- 17** We use water efficient washing machines and always wash a full load.
- 18** We use water efficient dishwashers and always wash a full load.

- 19** We wash dishes by hand and minimise our water use while doing so.
- 20** We collect rainwater from our roofs in tanks.
- 21** We water gardens using rainwater or greywater.
- 22** We only water gardens after sunset or before high sun and avoid watering in the middle of the day.
- 23** We are water conscious when we wash vehicles and use a bucket and not a hose.
- 24** We have natural (chemical-free) swimming pool(s) - we keep our pool water clean using an organic filtration system with aquatic plants.
- 25** We have salt water swimming pool(s).

F: Catering and Waste

- 1** We use locally produced fresh foods.
- 2** We use organic vegetables.
- 3** We use free-range meats.
- 4** We encourage vegetarian meals amongst our staff.
- 5** Vegetarian options are available at all meals on camps.
- 6** We have a vegetarian day on all camps.
- 7** We compost raw food waste.
- 8** We compost cooked food waste.
- 9** We do not throw away left-overs but use them for staff or local community feeding schemes.
- 10** We are committed to reducing the amount of waste we produce.
- 11** We avoid using disposable plates or cups for catering purposes, and if we do use them we ensure we select biodegradable or recyclable options.
- 12** We use reusable shopping bags when buying provisions for camps and when doing personal shopping.
- 13** We are committed to avoiding single-use plastic bags.
- 14** We avoid excessive packaging when shopping for food.
- 15** We are committed to being a plastic straw-free campsite.
- 16** We encourage all campers to bring a water bottle of their own, and we do not buy small plastic bottles of drink for campers.

17 We minimise waste that will end up on land-fill through the principles of

- Refuse
- Reduce
- Reuse
- Recycle

18 We have recycling facilities for staff and campers.

19 We are part of community schemes to reuse items before recycling them.

20 We participate in litter-picks.

21 We make Eco-bricks.

G: Land Management

- 1** We are committed to managing the land entrusted to our care to the glory of God.
- 2** We have a management plan for our land, based on the advice of environmental professionals who have visited the property.
- 3** We are working at eradicating non-native invasive species from our land.
- 4** We are working at restoring native vegetation.
- 5** We participate in responsible native tree planting, following guidance from environmental professionals.
- 6** We are committed to gardening organically (with the exception of necessary poisoning of invasive species).
- 7** Garden areas are planted with water-wise plants.
- 8** We use mulch on our gardens to reduce water loss through evaporation.
- 9** We grow our own vegetables on site.
- 10** We farm animals on site for the benefit of the environment.
- 11** We encourage native plants that benefit bird and insect life, and do not mow all our garden areas.
- 12** We provide safe habitat to encourage wildlife species (dog-free areas of native vegetation where hunting is prohibited).
- 13** Native wildlife is encouraged through the provision of bird boxes and/or bat boxes and/or bug hotels, etc. (please state what).
- 14** We regularly monitor our flora and fauna and keep records for research purposes.
- 15** We have employed a botanist to undertake a botanical survey.
- 16** We manage and care for our wetlands (ponds, lakes, streams, rivers) to sustain the wetland habitats for the benefit of all creatures.

- 17** We (or local ornithologists) do bird ringing/banding on our property to monitor birdlife.
- 18** We have trail cameras to monitor shy and nocturnal species.
- 19** We welcome experts in herpetology, entomology, etc.
- 20** We have a fire management plan in place for vegetation types prone to burning.

CCI EcoCare: Beliefs and Commitment

Statement of faith (in line with CCI)

We believe in:

- The Holy Scriptures as originally given by God, divinely inspired, infallible, entirely trustworthy, and the supreme authority in all matters of faith and conduct.

- Prayerfully committing to make lifestyle changes that will improve our stewardship of creation, regularly reassessing and challenging ourselves to continue making more changes to improve our creation care.
- Worshipping God through wise choices concerning the way we use the natural resources He has given us.
- Assessing how we can implement changes on our campsites to care for God's world and to promote creation care amongst our fellow staff and campers.
